1. BREEDER guarantees that the above dog is a purebred and registered with the American Kennel Club (AKC)
2. BREEDER cannot guarantee adult size, color, hair coat, temperament or trainability of the puppy.
3. BREEDER does not assume any liability for any injury or neglect to said puppy after delivery.
4. BREEDER warrants that this puppy has been wormed and vaccinated in accordance to its age and both parties agree that it appears apparently healthy at this time. Buyer realizes that the purchase of a live animal carries with it the risk of said puppy contracting various vermin, bacteria or viruses that are not in the control of either seller or buyer. Beyond the 72 hours to have the puppy checked with your vet, the seller offers NO Guarantee of infectious disease.
5. By signing this contract buyer agrees to all terms listed below. Puppy is to be spayed or neutered, males by 5 months of age and females by 6-7 months of age (unless puppy has been sold for breeding/show purposes and full registration is marked above). BUYER agrees

to have this puppy examined by a veterinarian within 72 hours of delivery.

IF after examination by a veterinarian acceptable to both parties, the puppy is determined to be IN POOR HEALTH, puppy MAY BE RETURNED to the seller WITH A WRITTEN REPORT FROM THE VETERINARIAN. The buyer can choose to get a replacement of another puppy of the same sex and value if one is available or soon available or to receive a refund of their money. At no time will the seller be responsible for any vet fees incurred.

6. BUYER agrees this puppy is sold with a 1 year guarantee against hereditary diseases. IF after examination by a veterinarian acceptable to both parties, the puppy is determined to have a disease, puppy may be returned to the seller (at the buyers expense) along with all paperwork and exchange for another pup of the same value. buyer can choose to keep the puppy and all the expenses that come with it. In some cases where the buyer chooses to keep a puppy that has a problem, the buyer can receive a partial credit toward a future purchase of a puppy while they have expenses in a puppy they choose to keep. Such circumstances are dependant upon expenses and life expectancy.

7. Buyer needs to be aware that a puppy is a baby and that sometimes may get sick due to stress or other related reasons. He is leaving our home and is entering a new environment and stress related sicknesses may occur. We try our best for a happy healthy puppy but proper care is a must. Buyer agrees to furnish proper care of quality food, water, shelter and veterinarian care for the life of the canine. Buyer agrees to notify Heartfelt Dachshunds if he/she is unable to care or keep teh canine at any time of its life. The breeder is given the first option to take canine back or find it a good home. No money will be refunded but please do not take the canine to the animal shelter.

8. Umbilical hernia is the most common type of hernia found in puppies and are often just "delayed closures" of the abdominal wall. In the case of the umbilical hernias, a portion of fat protrudes through an incompletely closed umbilical ring . These hernias may be present at birth or acquired as a result of the umbilical cord being severed too close to the abdominal wall by the mother. In most cases these are small and generally close as the puppy grows and usually shrink and disappear by the time the puppy is six months old. A small umbilical hernia is not life threatening and is no way interferes with the quality of the life of the puppy and it does not warrant a return of money.

In a case where an inguinal hernia is found, a portion of fat protrudes through the inguinal ring. The inguinal hernias are presented as skin-covered bulges in the groin. The can be bilateral, involving both sides , or unilateral, involving only one side. As with umbilical hernias most of the inguinal hernias with shrink and disappear as the puppy grows but you must keep an eye

on the size. Because of the size of the puppies, they can go unnoticed or undetected until the puppy is 6 to 8 weeks old or older. If we find a hernia at the time the vet checks the puppy to go home, we would reveal the hernia to the buyer and since a vet should not use anesthesia on a puppy until they are older than 12 weeks of age, if repair is warranted, I will refund \$75 towards the hernia repair by the buyers own vet. Hernia repairs do not warrant return of money as is not life threatening and in no way interferes with the quality of life for the puppy.

NEW 5 YEAR HEALTH GUARANTEE

As of Jan. 2017, Heartfelt Dachshunds is extending the one year health guarantee to 5 years for using the Life's Abundance Nutritional System which includes the food and supplements for their entire lifetime. This is replacing the 2 year guarantee we have offered in the past. We are extending our health guarantee for all puppies purchased this year and the end of 2016 to all customers who have used the products with no lapse in their use of the Life's abundance products with their puppies. The following are the products required and recommended for the program.

Purchases made from Life's abundance must be made either through the link on www.heartfeltdachshunds.com or through the website www.healthypetfoods.co or you can call 1877-387-4564 and give them my rep # 20071837 or my name (Lynda Carter) to make sure that it is tracked for the guarantee. Those links keep up with all purchases so you do not have to keep and maintain receipts for the 5 year guarantee.

Wellness Supplement (used as directed on package)

NOTE: Treats are not required for guarantee but are recommended. Using treats from other sources can be deadly. If any treat is used with your puppy from another company, it will void the guarantee. These are the recommended treats for the puppies. We also use fresh pieces of apples or carrots.

Beside other life's abundance treats-can be used over 4 months old as they are more for adults than puppies.
NOTE *All Life's abundance food and treats as well as our new product line being added from Flint River Ranch are acceptable for the 5 year guarantee for the puppy as it becomes an adult as long as the Food and wellness supplement are being used together.
